GENERAL AUCTION INFORMATION

BACKGROUND

The GW Equal Justice Foundation is a student organization devoted to encouraging public interest and community service work at GW. As a way of encouraging students to investigate public service careers, EJF provides summer grants to students performing uncompensated legal work for public interest organizations. These summer grants are funded by the Spring Auction which is completely dependent on donations. Last year, proceeds from the auction funded thirteen summer grants of \$2,200 each. The awards are made based on the student's prior commitment to public service and on participation in planning the auction.

PARTICIPATION

The auction is entirely student-run, so its success depends on our collective efforts. The more effort we put forth, donations we receive, and support we earn will translate directly into more dollars to give. It will also mean more fun for all of us! So encourage your friends and classmates to participate. Additionally, the success of each year builds on the last. Increased exposure and visibility this year will mean increased participation and donations next year, so let's step it up!

Every EJF grant recipient is involved in the auction in some way. The minimum contribution required to qualify for an EJF grant is at least 7 items for the auction, and 7 volunteer hours before or at the Auction.

- There will be opportunities to earn hours at table days, flyering, volunteering on Auction Day, and more.
- Any \$50.00 cash donation qualifies as an item (no more than two \$50 cash donations per individual volunteer).
- Of course, the more donations you can secure, the better!

SUCCESSFUL SOLICITING

All of the items sold at the EJF Spring Auction are donated by GW faculty and staff as well as by metroarea businesses. Soliciting donations is not hard; most of the people you contact will be interested in helping. EJF has compiled this solicitation packet to help make the solicitation process even easier.

The following helpful solicitation tools are included to help you along:

SOLICITING INSTRUCTIONS

Previous Donors:

- Visit or call the business at a time when the managers are likely to be available.
- If your list provides a contact name ask to speak with that person, otherwise ask to speak with a manager.
- Introduce yourself, telling them that you attend the GW Law school and are a member of the GW Equal Justice Foundation.
- Mention that they may have already received our letter, or will be receiving it shortly.
- Thank them for last year's donation.
- Remind them of the purpose of the Auction, and give them a copy of the Auction Fact Sheet.
- Mention that it helped fund \$2,400 grants for 8 students.
- Request their support for this year's auction.
- Have them complete the company donation form.
- THANK THEM!
- If they decline, politely thank them and inquire why.
- Update your student donation form to show who you contacted, when, and what they donated. (If they did not donate, note whether they wanted you to return, or if they gave a reason for declining.) *Email this information to tchatman@law.gwu.edu* after each new contact so that we can keep track of which donors have/have not been contacted.

New Donors:

- Same basics as above.
- If they are not familiar with the Auction, give them a copy of the fact sheet, and a brief explanation.
- Emphasize:
 - o The GW law school has a prominent presence in the D.C. community.
 - o Law students frequently visit all of the businesses being solicited and many students continue to do so even after graduation.
 - Advertising incentive Their business name will be printed on our Program, and announced with their auction item.
- Even if the donor declines to make a donation, please note on your student donation form that you contacted them. *Email this information to tchatman@law.gwu.edu* after each new contact so that we can keep track of which donors have/have not been contacted.

Additional suggestions:

- Don't restrict yourself to businesses in D.C, try contacting some in Maryland and Virginia.
- Utilize your own contacts if you've worked anywhere in the area or know someone who has. For example, if you've worked at a law firm, you may approach them about making a donation--many firms buy season tickets to various local events.
- FOLLOW UP, FOLLOW UP, FOLLOW UP! Persistent solicitors will be rewarded!!
- Please pace yourself by starting early, so that your persistence does not become bothersome. We
 will start the whole process off by contacting most potential donors by mail and organizing group
 solicitation events.
- Remember that the more money you raise, the more grants EJF can give out and the better your chances are of obtaining one.
- Below are just a few suggestions for donations but feel free to be creative.
 - Gift certificates to restaurants, bars, clubs, and theaters.
 - ♦ A week at your or your parents' vacation home.
 - ◆ Tickets to an athletic event.
 - ♦ Weekend hotel/BB stay.
 - ◆ Lunch with a notable person.
 - ◆ Signed books or pictures from notable / famous people
 - ♦ A round of golf on a private course and/or with a notable person.
 - ♦ Airline/train tickets.
 - ◆ Concert tickets and movie passes.
 - ♦ "Behind the Scenes" tour of the Smithsonian, White House, etc.

Receiving / Collecting Donations:

- Checks should be made out to the Equal Justice Foundation, and can be mailed along with the donation form to the address on the form.
- Product donations can be mailed with the donation form to the same address.
- Alternatively, you can pick up the donation along with the form, and put it in the EJF mailbox in the Records Office.
- If the item is too big for the mailbox, email George (gwu@law.gwu.edu).
- You are responsible for making sure that the donations you secure are collected in time for the auction.

Did you know that in 2002 almost 12% of the U.S. population lived below the federal poverty level, earning less than \$19,000 a year for a family of four? These people face unique legal problems associated with obtaining their most basic needs—such as food, housing, health care, and education—but attorneys trained to assist them are in short supply. The reason? As most law students know, law school is extremely expensive and funding for public interest careers is very limited.

Our organization, The Equal Justice Foundation, works to remedy this problem and to encourage students to explore public interest careers through our Summer Grant Program, which is funded by proceeds from a live auction attended by alumni, faculty and students. Last year the grant program provided thirteen grants of \$2,200 each to deserving students who worked full-time for a variety of public interest organizations. The following are just a few of the organizations for which our grant program has enabled students to work:

EJF AUCTION FACT SHEET

EVENT FACTS

- The EJF Auction is a student-run event, with a history of over 10 years of providing grants to students working in public interest summer positions. EJF grant recipients work in the D.C. community and throughout the country, serving the legal needs of the nation's neediest citizens.
- The event is one of the largest on the law school's campus, drawing over 1,000 attendees, including students, faculty, and administrators.
- Each year, the Auction raises between \$20,000 and \$30,000.
- Last year, proceeds from the Auction allowed EJF to provide 8 grants of \$2,400.
- The Auction is supported entirely by donations from the local and law school communities.
- Law school professors demonstrate their power of persuasion and comedic talent as our Auctioneers at the event.
- Each year, the Auction continues to grow, which means that each year, GW students can
 make an even greater contribution to their communities through the public interest work
 the auction funds. With your help, this year will be an even greater success!

PUBLIC INTEREST FACTS

- In 2001 almost 12% of the U.S. population lived below the federal poverty level, earning less than \$19,000 a year for a family of four.
- A nationwide survey of third-year law students last spring showed that 94% of respondents financed their legal education through loans. 50% of the students surveyed who graduated last spring had law school loan debts of \$75,000 or more.²
- A survey conducted by Equal Justice Works indicated that the majority of the 300+ employers responding report significant difficulty in recruitment and retention of public interest attorneys, mostly attributed to low salaries and educational debt.³

THE EQUAL JUSTICE FOUNDATION PUBLIC INTEREST SUMMER OF 2003 GRANT APPLICATION

WHO WE ARE:

The Equal Justice Foundation (EJF) is a student run organization offering summer grants to students working in the public interest field for the summer of 2004. Attached is an application for and related materials on how to obtain summer funding from the EJF. In past years, cash grants between \$1000-\$2500 have been awarded to students. The money raised during our spring auction determines the number of grants and the amounts awarded each year.

OUR GRANTS:

EJF grants are a student run funding program separate from the GW Public Interest Fellowship Programs. EJF grants cannot be used in conjunction with grants from the GW Public Interest Fellowship Programs. However, EJF grants may be combined with outside third party sources such as Equal Justice Works. We highly encourage students in need of funding to apply for funding from multiple sources so that more options may be available to them.

JOB POSITIONS REQUIRED:

An applicant seeking an EJF summer grant must have committed to work without pay for a public interest employer for a minimum of eight weeks for at least 40 hours or more per week. EJF defines a public interest employer as any 501(c)(3) organization, 501(c)(4) organization, OR any governmental organization that provides legal services for individuals and organizations that cannot otherwise afford legal services.

HOW TO APPLY:

A student seeking a summer grant from EJF must submit both a completed application and the attached forms detailing the hours they helped with the auction and the items they solicited for donation. A student applying for a summer grant will need to work a minimum of 7 hours before and/or at the auction event as well as donate a minimum of 7 items to be auctioned off at the event. Completed applications and relevant attachments are due in the EJF Mailbox in the Records Office by 2pm on Friday, April 9th. Decisions will be announced on Monday, April 12th.

Please include anything relevant to your commitment to public interest law. Please describe why you chose this job and what you hope to gain from the experience. If you are applying for a GW Public Interest Fellowship(s), you may submit the personal essay to EJF that you submitted for the GW Public Interest Fellowships.
- 3. Current Resume.
- **4.** Letter(s) of Reference. Not required but may be attached when relevant.
- 5. Certification.

I certify that the information contained in this application is correct. I understand that if the information is incorrect, or the requirements for application have not otherwise been met, I will not be eligible to receive an Equal Justice Foundation (EJF) grant. I understand that an EJF Board Member may verify this information at any time and any grant received may be revoked if cause is found. I agree to the grant selection process developed by EJF and will abide by its decisions.
